Gentlemen:

This letter refers to the special safeguards inspection of your activities authorized under NRC License No. NPF-10 conducted by Mr. A. D. McQueen, of this office on September 7 to November 3, 1982. It also refers to the discussions of our inspection findings held by the inspector with members of your staff on September 7 and 10, October 5, and November 12, 1982.

The inspection included examination of activities related to your program for (physical Protection against industrial sabotage and against theft of special nuclear material in accordance with applicable requirements of Title 10, Code of Federal Regulations, Part 73, "Physical Protection of Plants and Materials",) and pertinent license conditions as described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and records, interviews with facility personnel and observations by the inspector.

Based on the results of this inspection it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. Pursuant to the provisions of 10 CFR 2.201 you are required to respond as indicated therein.

In accordance with Section 2.790(d) of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, documentation of findings of your security procedures are exempt from disclosure; therefore, the enclosures to this letter, the inspection report, and your response to the item listed in the enclosure to this letter will not be placed in the Public Document Room and will receive limited distribution.
