A proposed amendment to the McGuire Unit 1 Technical Specifications is attached. The amendment is submitted to revise Specification 3/4.2.3 including Figure 3.2-3. "RCS Total Flowrate Versus R1 and R2 - Four Loops in Operation" based upon a reduced measurement uncertainty for RCS flowrate.

Attachment 1 describes the proposed amendment and Attachment 2 contains a discussion of the justification and safety analysis. Pursuant to 10 CFR 170.22, a check for \$4,000 is enclosed for this Class III amendment.
