## CONFIDENTIAL

During conversations with the staff, inquiries were made concerning Question 2 of the Licensed Operator Fitness-for-Duty Questionnaire. The questionnaire addressed a Fitness-for-Duty occurrence on November 29, 1993, involving a licensed operator. Question 2 of the questionaire requested a summary of the operator's entire Fitness-for-Duty testing history which was provided in paragraph 2 (a) of the original submittal. Waterford 3 also provided, in paragraph 2 (b), information concerning pre-Fitness-for-Duty (10CFR26) testing. In response to the verbal inquiries, Waterford 3 provided additional information in response to Question 2 of the questionnaire in a telecon with the staff on January 27, 1994.

This submittal documents the information that was provided in the telecon. Please note that this information represents drug testing that was performed outside of the Waterford 3 Fitness-for-Duty program to which Waterford 3 had no knowledge of or access to at the time of the original submittal.

The operator was submitted to off-site drug testing by the treatment center to which he applied for admission on November 28, 1993. The test results were positive for cocaine use. On December 6, 1993, the operator was again tested off-site and the drug test results on that date were negative.

It is important to note based on conversations between Waterford 3's MRO and the attending physician that it appears the drug testing program used by the treatment center meets most of our testing requirements. Specifically, the program uses the same cutoff levels and the same testing process, however, the treatment center does not use chain of custody as is required for Waterford 3 per IOCFR26.
