SUBJECT: REQUEST FOR WITHHOLDING INFORK (ION FROM PUBLIC DISCLOSURE MILLSTONE NUCLEAR POWER STATION, UNIT NO. 2 (TAC NO. M86361)

By your affidavit dated November 24, 1993, and Northeast Nuclear Energy Company's (NNECO's) letter dated November 30, 1993, it was requested that the "Response to Request for Additional Information (TAC No. M86361) Detailed Seismic and Structural Information (Proprietary); "Spent Fuel Rack Information Millstone 2 Spent Fuel Storage Pool Modification," be withheld from public disclosure pursuant to 10 CFR 2.790.

You stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- The information sought to be withheld from public disclosure, which is owned and has been held in confidence by Combustion Engineering, is modeling and structural analysis of the Millstone Unit 2 spent fuel storage racks supplied by Combustion Engineering.
- The information consists of test data or other similar data concerning a process, method or component, the application of which results in substantial competitive advantage to Combustion Engineering.
- 3. The information consists of specific models, methodology, and data used for the structural analysis of the Millstone Unit 2 spent fuel storage racks supplied by Combustion Engineering, the application of which provides a competitive economic advantage. The availability of such information to competitors would enable them to modify their product to better compete with Combustion Engineering, take marketing or other actions to improve their product's position or impair the polition of Combustion Engineering's product, and avoid developing similar data and analyses in support of their processes, methods or apparatus.

If the need arises, we may send copies of this information to our consultants working in this area. We will, of course, ensure that the consultants have sign in the appropriate agreements for handling proprietary information.

If the basis for withholding this information from public inspection should change in the future such that the information could then be made available for public inspection, you should promptly notify the NRC. You should also understand that the NRC may have cause to review this determination in the future, such as, if the scope of a Freedom of Information Act request includes your information. In all review situations, if the NRC makes a determination adverse to the above, you will be notified in advance of any public disclosure.
