Subject: Combined Inspection Report Nos. 50-334/91-01; 50-412/91-01

This refers to the routine safety inspection conducted by Mr. A. Finkel of this office from January 8 - 11, 1991, at Beaver Valley Power Stations Units 1 and 2, Shippingport, Pennsylvania, of activities authorized by NRC License Nos. DPR-66 and NPF-73 and to the discussions of our findings held by Mr. Finkel with Mr. W. Lacey of your staff at the conclusion of the inspection.

During this inspection, two non-cited violations were identified involving the failure to transcribe higher level procedure requirements into lower tier procedures. This occurrence was an isolated event of minor safety significance; and, because of the adequacy of the corrective actions taken, the violations are classified as non-cited violations.

No reply to this letter is required. Your cooperation with us in this matter is appreciated.
