The purpose of this modification is to provide incremental funding in the amount of \$1,580,000.00 which increases the amount obligated to the task order from \$3,749,400.00 to \$5,329,400.00. Accordingly, the following change is hereby made:

The fourth paragraph, first sentence, of the definitization letter is revised to read as follows:

"The amount presently obligated with respect to this task order is \$5,329,400.00 of which \$5,124,423.08 represents the reimbursable costs and the amount of \$204,976.92 represents the fixed fee."


