REQUEST FOR TECHNICAL ASSISTANCE

Louisiana Energy Services (LES) submitted, on January 31, 1991, its application for a license for a gas centrifuge uranium enrichment plant. The application will be considered pursuant to the requirements of 10 CFR Parts 40 and 70, as well as special standards and instructions that will be provided in a Commission Notice and Order currently in preparation. The special standards and instructions are primarily to implement, prior to making conforming rule changes, amendments to the Atomic Energy Act contained in the recently enacted Solar, Wind, Waste, and Geothermal Power Production Incentives Act of 1990 (P.L. 101-575).

By this memorandum, I request the assistance of your staff in reviewing LES' provisions for liability insurance and LES's financial qualifications for constructing and operating the plant. In addition to performing the reviews, written discussions of the reviews and their consequent conclusions are needed for inclusion in the staff's Safety Evaluation Report. A schedule related to these reviews is enclosed. P.L. 101-575; applicable sections of LES' application, when docketed; and the Commission Notice and Order, when published in the Federal Register, will be provided to your staff.
