This letter is in response to the Notice of Violation which was transmitted with the above-referenced letter. This notice was issued as a result of the findings stated in Inspection Report No. 50-409/90002 (DRSS).

NOTICE OF VIOLATION

A licensee review of audit requirements in June 1990 identified the failure to perform a required audit of the Radiological Environmental Monitoring Program (REMP). The failure was reported in Licensee Event Report (LER) No. 90-03, dated July 6, 1990, where it was attributed to a scheduling error. However, the problem was not promptly corrected and the audit remained undone until November 1990 when it was noted to be in progress during the current inspection.

Technical Specification 6.5.2.8.j requires that audits of the Radiological Environmental Monitoring Program (REMP) and results shall be performed at least once per 12 months under the cognizance of the Safety Review Committee.

Contrary to the above, an audit of the REMP and results was not performed since January 1, 1989.

This is a Severity Level V violation (Supplement IV).

This audit is being sent as an attachment to this letter. Corrective Steps Taken to Avoid Further Violations As stated in LACBWR's LER #90-03 (Reference 2), the Quality Assurance audit program schedule was changed back to the previous audit frequency which had been changed by the Quality Assurance Department in anticipation of a technical specification amendment for SAFSTOR conditions. The technical specifi 'ion amendment has not yet been received. The Director of Quality Assurat will monitor the audit needs at LACBWR to ensure all required aud's are performed promptly as required by the existing technical specifications.
