Subject: Modification No. 3 to Task Order No. 1 entitled, "Financial Training for Allotment Financial Managers and Fund Certifiers" Under Contract No. NRC-38-92-281

The purpose of this modification is to (1) provide for a within scope change, (2) to increase the task order ceiling and obligated amounts by \$8,946.00 and (3) extend the period of performance. Task Order No. 1 is modified in accordance with the attached Statement of Work and the contractor's proposal dated October 22, 1993.

Task Order No. 1 shall be in effect from July 28, 1993 through February 28, 1994. The cost ceiling of this task order is increased by \$8,946.00 from \$69,786.00 to \$78,732.00. The total estimated reimbursable cost amount is increased by \$8,283.00 from \$65,670.00 to \$73,953.00 and the fixed fee is increased by \$663.00 from \$4,116.00 to \$4,779.00.




