ORDER

On November 8, 1990, the Environmental Conservation Organization ("ECO" or "petitioner") filed a document entitled "Comment on Proposed No Significant Hazards Consideration and Petition for Leave to Intervene and Request for Prior Hearing" regarding an application by the Sacramento Municipal Utility District ("SMUD" or "licensee") for an amendment to Ranch Seco operating license. The proposed amendment would "remove the licensee's authority to operate the Rancho Seco facility." Pursuant to 10 C.F.R. § 2.772(k), this

petition is forwarded to the Atomic Safety and Licensing Board for further proceedings in accordance with 10 C.F.R. Part 2.\*


