Subject: Modification No. 6 to Task Order No. 2  
Under Contract No. NRC-02-91-001

The purpose of this modification is to provide incremental funding in the amount of \$75,000 and to correct the breakout of the estimated reimbursable cost and the fixed fee amounts reflected in Modification Nos. 4 and 5.

The ceiling with respect to Task Order No. 2 remains at \$434,507.00 of which \$399,647 represents the total estimated reimbursable costs and the amount of \$34,860 represents the fixed fee. Modification No. 4 should have reflected \$225,137 in total estimated reimbursable costs and \$19,852 in fixed fee. Subsequently, Modification No. 5 should have reflected \$399,647 in total estimated reimbursable costs and \$34,860 in fixed fee. The obligated amount of the subject task order is increased in Modification No. 6 by \$75,000.00 from \$312,489.00 to \$387,489.00 of which \$69,060.77 represents the reimbursable costs and \$5,939.23 represents the fixed fee.




