SUBJECT: NRC Inspection No. 50-293/94-03

An announced safety inspection of the radiological controls program at your facility was conducted by Mr. J. Noggle on January 31 - February 4, 1994. The inspection results were discussed with you and members of your staff on February 4, 1994.

Areas reviewed during the inspection are important to health and safety and are discussed in the enclosed inspection report. These areas included review of: audits and surveillances, training and qualifications, radiological problem reports, and external exposure control programs. We noted the recent enhancement of the radiological controlled area access control system. The new computer system has added personnel access lists to the radiation work permits (RWPs) that now limit unauthorized personnel from using the wrong RWP. Additional briefing requirements have been imposed on personnel utilizing general RWPs, which previously did not require any HP staff interface. These are good control measures that strengthen your radiological controls program.

Your problem report program continues to effectively identify station problems. One weakness was noted in that the problem report program threshold may be too high to identify, for thorough review and resolution, some significant radiological safety issues. Your staff made a commitment to revise this threshold, which should provide the additional attention to this area.

In addition, we received your December 24, 1993 letter in response to a Notice of Violation issued with Inspection Report No. 50-293/93-16. As described in the enclosed inspection report, during the inspection we reviewed your corrective actions and have closed out this violation.

No safety concerns or violations of NRC regulatory requirements were identified during this inspection.

Your cooperation with us is appreciated.
