SUBJECT: COMBINED REGION I INSPECTION REPORT NOS. 50-317/94-06 AND 50-318/94-06

This letter transmits the NRC Region I inspection report for the routine, announced inspection conducted by Mr. A. Finkel of this office for the week of January 31 through February 4, 1994, at the Calvert Cliffs Nuclear Power Plant. Mr. Finkel discussed the results of the inspection with Mr. F. Deller and other members of your staff on February 3, 1994.

The inspection was directed towards areas important to public health and safety. Areas examined in this inspection included the resolution of open items identified in previous NRC inspection reports. Within this scope, the inspection consisted of selective examinations of design records, system evaluations, drawings, procedures, and representatives records; interviews with personnel; and observations by the inspector. Corrective actions for two previously-identified violations were found to be adequate and these items were closed. No additional violations or concerns were identified.
