NOTICE OF ISSUANCE OF AMENEMENT

FACILITY OPERATING LICENSE NO. NPF-10

The U. S. Nuclear Regulatory Commission (the Commission) has issued Amenment No. 11 to Facility Operating License No. NPF-10, issued to Southern California Edison Company, San Diego Gas and Electric Company, The City of Riverside, California and The City of Anaheim, California (licensees) for the San Onofre Nuclear Generating Station, Unit 2 (the facility) located in San Diego County, California. This amendment is effective December 6, 1982.

Amendment No. 11 changes the technical specifications applicable to turbine overspeed protection to allow steam flow in low pressure steam leads in which an inoperative reheat intercept valve is located, and to allow immediate return to power in the event of an inadvertant turbine trip.

Issuance of this amendment complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's regulations. The Commission has made appropriate findings as required by the Act and the Commission's regulations in 10 CFR Chapter I, which are set forth in the license amendment.

Prior public notice of this amendment was not required since the amendment does not involve a significant hazards consideration.
