## Gentlemen:

This letter is our response to your request that we modify the schedule for requalification examinations planned for the Braidwood Station in April 1991.

Members of your Braidwood staff met with members of my staff on December 18, 1990, to present a basis for changing our plans to administer requalification examinations. Our initial schedule for the weeks of April 1 and 8, 1991, was not consistent with your crew rotation. Following the December meeting we mutually agreed to move the examination to the weeks of April 8 and 15, which is consistent with Braidwood crew rotation for training.

During a second meeting on January 23, 1991, further concerns were expressed by Braidwood representatives regarding the week of April 15 and their apprehension related to potential operator performance problems on the simulator portion of the requalification exam. Your staff was concerned that the operators scheduled for the second week of the exam would not have the benefit of any recent simulator training. This led us to conclude that your practice of administering training on the simulator for one week immediately prior to the requalification exam weighs heavily on their confidence for a successful exam and may bolster an artifically high crew performance level. We understand that the operators in the second week of our examination would be evaluated under different conditions than the first group and, as a result, may be subjected to a level of stress significantly higher than those examined during the first week.

In view of the extenuating circumstances we agree to change our schedule in this instance. We presently plan to conduct the exam during the weeks of April 8 and April 22, 1991. Future NRC requalification examinations should be scheduled to preclude training that could potentially enhance the operators' performance in the short term. It is our intent to evaluate operators during the course of the requalification cycle at a point where the performance of operators is at a normal level.
