This letter refers to the inspection conducted by Mr. M. E. Skow and Ms. L. L. Gundrum of this office from December 6, 1990, through January 16, 1991. This inspection pertained to activities authorized for your Wolf Creek Generating Station. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection included plant status, operational safety verification, surveillance observation, maintenance observation, followup on a previously identified NRC item, review of licensee event reports, and cold weather preparations. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. The inspection findings are documented in the enclosed inspection report.
