Region V received telephone notification at 12:30 pm, PST, December 7, 1982 from the Acting Station Security Supervisor at Diablo Canyon Power Plant (DCPP) of the arrest at 10:00 am, PST, December 7, 1982 of a John Arthur JUNOT, male, age 34 years, residing in Hollywood, California. JUNOT was arrested by ATF Agents (Van Nuys Office) at Shell Beach, California, approximately 9 miles from DCPP and charged with: Possession of Three Destructive Devices with Intent To Use Them To Destroy or Damage Portions of Diablo Canyon Power Plant. JUNOT is not employed at DCPP According to ATF and licensee information, he has never been at the site, and apparently interded to enter the licensee's property at the outer rear gate and attempt to locate the plant. JUNOT was arraigned before US Magistrate SEITZ at 12:45 pm, PST, December 7, 1982 and bail was set at \$50,000. JUNOT remains in custody in San Luis Obispo, California. Media interest is expected and no press release is planned by the licensee or Region V.
