SUBJECT: NOTICE OF VIOLATION  
(NRC INSPECTION REPORT NOS. 50-413/90-32, 50-414/90-32)

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by the resident inspectors on December 9, 1990 to January 5, 1991. The inspection included a review of activities authorized for your Catawba facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation. The subject of the Violation, failure to perform periodic review of procedures, was previously identified in a recently completed NRC Maintenance Team Inspection indicating the possibility of a generic issue.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. It is also requested that you discuss the generic implications pertaining to the issue of periodic review of procedures. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

In accordance with 10 CFR 2.790(a), a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
