In accordance with 10 CFR 50.59 and 10 CFR 50.90, GPU Nuclear Corporation operator of the Oyster Creek Nuclear Generating Station, Provisional Operating License No. DPR-16, requests changes to Appendix A of that license.

The subject Technical Specification Change Request involves Sections 3.5.A.8, 4.5.Q, and 6.10.2, the corresponding bases, and Table 3.5.1. Sections 3.5.A.8, 4.5.Q and 6.10.2 shall be revised per your Revision 1 of the Inservice Inspection Surveillance Requirements for snubbers under the Standard Technical Specifications which were transmitted by the D. G. Eisenhut letter of March 23, 1981. Table 3.5.1 shall be revised to add the mechanical snubbers.

The Technical Specification Change Request has been reviewed by the Plant Operations Review Committee and an Independent Safety Review Group in accordance with Section 6.5 of the Oyster Creek Technical Specifications.

It is requested that the effective date of this Technical Specification Change Request be thirty days after being approved by the NRC.


