The status of the five proposed changes to the VY Technical Specifications (TSs) currently under NRC staff review was discussed. In addition, the status of other open issues was discussed, including a recent licensee request for relief from requirements for inspection of feedwater nozzles during the licensee's 1995 refueling outage. The licensee noted this as a high-priority issue for VY, as it will affect the outage planning.

The licensee discussed several initiatives it has in process to evaluate the need for changes to the TS in several areas. These areas include administrative changes to clarify ambiguities in the TS, surveillance requirements and their associated implementing procedures, and commitments made by the licensee in Licensee Event Reports (LERs). The staff responded that it, too, was reviewing concerns regarding the need to improve the VY TS. The staff noted that several 1993 LERs included issues related to ambiguous TS or improper TS interpretation. In addition, several other 1993 LERs reported personnel errors or inadequate procedures resulting in missed TS-required surveillances. Finally, the staff noted several examples of TSs which the staff has identified as unclear due to a lack of adequate documentation of the licensing basis. The licensee noted that it is preparing proposed TS changes which address some of the staff's concerns.
