VOGTLE ELECTRIC GENERATING PLANT
PHYSICAL SECURITY AND CONTINGENCY PLAN AMENDMENT 20

In accordance with 10 CFR 50.54(p), Georgia Power Company hereby submits three copies of Amendment 20 to the Vogtle Electric Generating Plant Unit 1 and Unit 2 Physical Security and Contingency Plan (the Plan). By copy of this letter, two copies of Amendment 20 are being sent to the NRC Region II office.

Amendment 20 incorporates changes to the Plan initiated as a result of improvements recommended by the Regulatory Effectiveness Review (RER) team and implemented as a result of changes in the definition of a physical barrier, which appeared in the 1989 Edition of the Code of Federal Regulations. Enclosure 1 provides a description and justification of the changes while Enclosure 2 provides insertion instructions and revised Plan pages. Enclosure 3 provides the actual change to the security plan. Enclosure 4 provides the new effective page list.
