This refers to your letters dated September 30 and November 29, 1982 in response to our letter dated August 30, 1982.

Thank you for informing us of the corrective and preventive actions documented in your letters. These actions will be examined during a future inspection of your licensed program.

Based on a conversation between yourself and Mr. C. Cowgill of our office on October 28, 1982, we understand that actions with respect to Appendix A of our August 30, 1982 letter will be completed as follows. For Item A, required reading was to be completed by October 30, 1982. For Item B, all actions, including required reading, issue of a revised equipment control procedure, and attendant training will be completed by December 1, 1982.

With regard to Appendix B of our August 30, 1982 letter. we have reviewed your response and the Dyster Creek Safeguards Contingency Plan. Based on this review, the violation is rescinded and our records will be corrected accordingly. Further, we concur in your commitment to revise the Contingency Plan and implementing procedures and believe that this will alleviate future misunderstandings.

Since the time of that inspection, our inspector brought to your attention a matter relating to the conduct of an on-duty Site Protection officer. This matter was discussed with you in a telephone conversation on November 18, 1982 by Mr. R. R. Keimig of this office. That conversation also included a discussion of GPU Nuclear Corporation's policy with regard to such matters which includes strict disciplinary action. We understand that appropriate action was taken in this case and have no further questions.

In accordance with 10 CFR 73.21 of the NRC's regulations, documentation of findings of your facility security measures for physical protection are deemed to be Safeguards Information. Each person who produces, receives, or acquires Safeguards Information is required to ensure that it is protected against unauthorized disclosure. Therefore, Appendix B of your letter will not be placed in the Public Document Room and will be distributed pursuant to 10 CFR 73.21.
