- The Nuclear Regulatory Commission (the Commission or the NRC) having found that:
 - A. The application for amendment filed by the Commonwealth Edison Company, dated November 18, 1982 and December 7, 1982, complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's regulations set forth in 10 CFR Chapter 1;
 - B. The facility will operate in conformity with the application, the provisions of the Act, and the regulations of the Commission;
 - C. There is reasonable assurance: (i) that the activities authorized by this amendment can be conducted without endangering the health and safety of the public, and (ii) that such activities will be conducted in compliance with the Commission's regulations; set forth in 10 CFR Chapter I;
 - D. The issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public; and
 - E. The issuance of this amendment is in accordance with 10 CFR Part 51 of the Commission's regulations and all applicable requirements have been satisfied.
- Accordingly, paragraph 2.5 of the Facility Operating License No. NPF-11 is hereby amended to read as follows:

D. Exemptions from certain requirements of Appendices G, H and J and and 10 CFR Part 73 are described in the Safety Evaluation Report and Supplement No. 1, No. 2 and No. 3 to the Safety Evaluation Report. In addition, an exemption was requested until the completion of the first refueling from the requirement of 10 CFR §70.24 and an exemption from 10 CFR Part 50, Appendix E from performing a full scale exercise within one year before issuance of an operating license, both exemptions are described in Supplement No. 2 of the Safety Evaluation Report. Finally, an exemption was requested from the requirements of 10 CFR §50.44 until either the required 100 percent rated thermal power trip startup test has been completed or the reactor has operated for 120 effective full power days as specified by the Technical Specifications.
