Wissink" ("Affidavit") dated July 15, 1988. The Nuclear Regulatory Commission (NRC) postponed a decision on 3M's Application pending resolution of 3M's similar request ("Request") about the February 25, 1988 Battelle Pacific Northwest Laboratories ("Battelle") Report. By letter dated January 9, 1989 (Enclosure 1), NRC notified you of its decision on that report. By letter dated April 25, 1989 (Enclosure 2), we informed you that the issues and documents in 3M's Request are similar to those in 3M's Application. We asked you to provide marked copies of the documents 3M is requesting be withheld, showing those portions of the documents that contain evaluations and conclusions. We also offered 3M the opportunity to present additional documentation to support its request for withholding. 3M's reply dated June 23, 1989 did not provide marked copies of all documents as requested. Rather, 3M asked NRC to: withhold, in their entirety, three reports of 3M Task Forces and Exhibits D and E to the Application; withhold certain portions of Battelle Reports dated March 16, 1988, April 20, 1988, and May 31, 1988; and release Battelle letter dated July 7, 1988.
