
Dear Mr. Davis:

In response to your notification of the requirements of regulation 10 CFR 30.35 in which licensees are to submit a decommissioning funding plan or certificate of financial assurance for decommissioning be provided to your office. Please find enclosed the latest abendment to the license listed above. It is my understanding that the limits set for Cobalt 60 sealed sources is ten thousand curies. Our present source is a 6200 curie, which is well below the set limit. Do to the size of our source it was my understanding we would not be required to submit a plan for decommissioning or a certificate of financial assurance. Also in our latest license amendment, condition 15 shows us to be exempt from this regulation.

If my understanding in this matter is wrong and I am misreading the regulation and the listed condition, I am eager to correct this possible error.
