Subject: Modification No. 8 to Task Order No. 06
Under Contract No. NRC-39-89-133

The purpose of this modification is to: (1) increase the level of effort as described in the attached Statement of Work, (2) authorize overtime support (128 hours x premium rate of \$11.78) in accordance with FAR Clause 52.222-2, Payment for Overtime Premiums (APR 1984), (3) extend the period of performance through January 31, 1992, (4) increase the contract ceiling amount, and (5) provide incremental funding in the amount of \$127,401.52. Accordingly, the following changes are hereby made:

1. Overtime is authorized for data entry operators for the purpose of entering T&A data into the NRC Payroll System and entering NRC accounting records into the IFMIS System. The contractor shall provide data entry operators to work overtime for the period February 1, 1991 through March 15, 1991.

Therefore, the total number of hours authorized for overtime under the subject task order to-date are 578 hours.

2. The third paragraph of the definitization letter for this task order is revised to read as follows:

"Task Order No. 06 shall be in effect from February 1, 1989 through January 31, 1992 with a total cost ceiling of \$683,582.62. The amount of \$635,803.50 represents the total estimated reimbursable costs and the amount of \$47,779.12 represents the fixed fee."

As a result of this extension through January 31, 1991, the level of effort for regular hours for this task order is hereby increased by 16,000 hours from 20,562 to 36,562 hours.

3. The fourth paragraph, first sentence, of the definitization letter is revised to read as follows:

"The amount presently obligated with respect to this task order is \$502,804.40 of which the amount of \$467,608.09 represents the total reimbursable costs and the amount of \$35,196.31 represents the fixed fee."

STATEMENT OF WORK
MODIFICATION NO. 8 TO TASK ORDER NO. 06
UNDER CONTRACT NO. NRC-39-89-133

Description of Work

The contractor shall provide data entry support using "Data General" CRT terminals located in the Maryland National Bank Building, Bethesda, Maryland, for the purpose of entering NRC payroll information into the payroll system and entering NRC accounting records into the IFMIS. The payroll data will be entered from the following forms:

- NRC Form 704 - Time and Attendance
Approx. 3700 bi-weekly
- CFC-840-Year - Combined Federal Campaign
Approx. 2500 annually
- Form 2809 - Health Benefits
Approx. 1000 annually

The volume of data for entering accounting records is approximately 400,000 documents per year, with each document containing an average of 100 characters.

The contractor shall verify that all data submitted by NRC has been entered accurately.

Level of Effort

The increased level of effort is estimated to be 16,000 regular hours and 128 overtime hours for data entry support.

Deliverables

The contractor shall provide Data Entry Support for approximately 128 hours of overtime hours being February 2, 1991, approximately 12,000 regular hours for the period May 1, 1991 through January 31, 1992, and approximately 4,000 regular hours for the period February 4, 1991 through January 31, 1992.

Period of Performance

The period of performance for the subject task order shall be through January 31, 1992.
