This refers to the routine safeguards inspection conducted by W. J. Tobin of this office on February 7-11, 1983, of activities authorized by NRC License No. DPR-23 at H. B. Robinson Steam and Electric Plant and to the discussions of our findings held with Mr. R. B. Starkey, Jr., Plant Manager, at the conclusion of the inspection. This also refers to the previous review conducted by Mr. W. Tobin on January 24-26, 1983, of your internal investigation of controlled substance abuse, and to his discussions with Mr. R. Lumsden, Assistant to the Vice President for Nuclear Operations, at the conclusion of the review.

Areas examined during this inspection included your physical security program as implemented under the provisions of Title 10, Code of Federal Regulations, Part 73, "Physical Protection of Plants and Materials" and the specific requirements of your approved Security Plan. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, performance tests, and observations by the inspectors.

Within the scope of this inspection, no violations or deviations were disclosed.

We have examined actions you have taken with regard to previously reported unresolved matters. The status of these items is discussed in the enclosed report.
