Gentlemen:

By letter dated February 17, 1983, your Company remitted fees totalling \$12,700 for your November 5, 1982 application regarding the ANO-1 and ANO-2 spent fuel pools. In our letter dated December 15, 1982, we informed you that Class IV and I fees (\$12,700) were appropriate for your November 5 application. However, we requested that your Company pay only \$8,700 because we were applying a refund of \$4,000 due on your April 2, 1982 application (Appendix H exemption for ANO-1) to the November request. Since you have paid \$12,700 for the November 5 application, we are authorizing the Division of Accounting and Finance to refund the \$4,000 for the April 2 application. Refunds are generally processed within a two-week period.
