THIS RESPONDS TO YOUR LETTER DATED JULY 15, 1980.

- 1. PARAGRAPHS 2-4 REPEATS THE TEXT OF A TELEX I SENT TO YOU ON JULY 9 IN RESPONSE TO YOUR TELEX OF JULY 4.
- 2. TMI, UNIT 1, EXPERIENCED A REACTOR COOLANT SYSTEM OVERFLOW ON JUNE 27. THE FOLLOWING IS THE TEXT OF THE PRELIMINARY NOTIFICATION ON THE EVENT.
- 3. AT 9:01 A.M. EDT. JUNE 27, 1980, AN INADVERTENT EMERGENCY
  SAFEGUARDS (ES) SYSTEM WAS ACTUATED, WHILE THE REACTOR WAS IN COLD
  SHUTDOWN WITH THE RCS PARTIALLY DRAINED FOR EDDY CURRENT TESTING. RCS
  WATER LEVEL WAS BEING MAINTAINED NEAR THE REACTOR VESSEL INLET AND OUTLET
  NOZZLE HEIGHTS AND ONE DECAY HEAT PUMP WAS PROVIDING RECIRCULATION
  COOLING. AFTER THE ES ACTUATED, THE DECAY HEAT SUCTION ISOLATION VALVE
  FROM THE BORATED WATER STORAGE TANK (DH-V5A) AUTOMATICALLY OPENED AT

  9:02 A.M. THE OPEN VALVE ESTABLISHED A FLOW PATH FROM THE

  BUST THROUGH THE OPERATING DH PUMP TO THE

  OFFICE SURNAMED.

MANUALLY SHUT DH-V5A. AT THAT TIME BOTH THE UPPER AND LOWER MANWAY COVERS AND THE LOWER HANDHOLE COVER HAD BEEN REMOVED FROM THE "B" STEAM GENERATOR IN PREPARATION FOR PLUGGING ONE TUBE LATER TODAY, AND NO ONE WAS INSIDE THE STEAM GENERATOR. ABOUT 10,000 GALLONS OF WATER WAS TRANSFERRED FROM THE BWST INTO THE RCS AND OUT THE LOWER HANDHOLE ONTO THE REACTOR BUILDING FLOOR AND TO THE BUILDING SUMP DURING AND AFTER THE TIME WHEN DH-V5A WAS COEN. THE RB SUMP WAS INTENTIONALLY PUMPED TO THE AUXILIARY BUILDING SUMP TO REVENT OVERFLOW. THERE WAS AT NO TIME A LOSS OF DH SYSTEM COOLING OF THE RCS. NO PERSONNEL CONTAMINATION OR OFFSITE RELEASE OCCURRED.

- 4. TMI, UNIT 2, HAS BEGUN THE PROGRAM TO VENT THE CONTAINMENT OF
  RADIOACTIVE KRYPTON GAS. NRC HAS SENT TWO TECHNICAL NOTIFICATION CABLES.
  NUMBERS 80-7 AND 80-8, THROUGH STATE DEPARTMENT CHANNELS TO DR. SETHNA, AND
  INFORM ME IF HE HAS NOT RECEIVED THE INFORMATION.
- 5. I AM ATTEMPTING TO OBTAIN COPIES OF THE ABNORMAL OCCURRENCES REPORT
  COVERING THE PERIOD JULY 1977 THROUGH DECEMBER 1978 AND HOPE TO SEND THEM IN
  THE NEAR FUTURE. NRC WOULD APPRECIATE RECEIVING ABNORMAL OCCURRENCE INFORMATION
  COMPILED ON THE OPERATION OF THE TARAPUR REACTORS. IS THIS POSSIBLE?
- 6. I AM ALSO SENDING YOU INFORMATION DIRECTLY BY TELEX THAT I AM SENDING TO DR. SETHNA THROUGH U.S. STATE DEPARTMENT CHANNELS. THESE TELEXS CAN BE IDENTIFIED BY THE SUBJECT LINE THAT ENDS WITH A NUMBER SUCH AS NRC 80-12, ETC. PLEASE ADVISE ME THAT YOU ARE RECEIVING MY TELEXS. REGARDS, LAFLEUR, NRC. END
