- 1. Nite-Site, Inc., recognizes the importance of assuring that the label is permanently attached to the weapon. We also recognize the fact that a fire-arm is a personal piece of equipment and not something that would be passed along to other hands. However, we feel the licencee should refer to the label as a definite part of the system.


 We have had, on occation, an officem that was reluctant to send his/hers handgun grips or buttplate to Nite-Site for attachment of the labels. To ensure that the labels are permanently attached to the weapon, a signed affidavit by the licensee is obtained. This affidavit serves two purposes. One, a licensee has his or hers attention drawn to the importance of the labels and the other is that our records will indicate that the labels are attached to the weapon. (Inclosed is a sample of the affidavit card)
- 2. Regarding the quarterly reports, we had not sent the recipients names and addresses because of a misunderstanding of the requirement.

 In the past, we reported only the number, identification and related information of the devices on our quarterly reports. The names, addresses and departments recieving the gunsights were logged in our record book for inspection by Mr. O'Berg. A current list of the recipients is inclosed.

 Mr. O'Berg also left us a list of names and addresses of the Agreement States and they will receive a copy of the licensees.

 In the future, all information will be supplied to the N.R.C. and to the Agreement State Agencies.

Regarding the possession limit of 75 millicuries of Promethium-147 as sealed luminous sources was pointed out by Inspector O'Berg. I explained to Mr. O'Berg that I thought the possession limit was 300 millicuries as stated on the supplementary sheet of License No. 22-13585-01, Amendment No. 6, dated March 19, 1974.
