This letter refers to the above subject physical security and fitness-for-duty inspection of the Haddam Neck Nuclear Power Plant by Messrs. A. Della Ratta and E. B. King of this office. Areas examined during the inspection are described in the enclosed report. Within these areas, the inspection consisted of selective examinations of security procedures and representative records, interviews with personnel and observations by the inspectors. Our preliminary findings were discussed by Mr. Della Ratta with Mr. J. LaPlatney and other members of your staff at the conclusion of the inspection.

We found that your physical security program is effective and directed toward assuring public health and safety. Appropriate management attention to security was evident in the continuing management review of overall program implementation and effectiveness, and in support for upgrades and enhancements. No safety concerns or violations of regulatory requirements were identified. However, during the inspection, a commitment was obtained from your staff to revise the vehicle control program to ensure that all vehicles parked inside the protected area as designated licensee vehicles (DLV) are on the list of DLVs. This issue is further discussed in Section 5.3 of the enclosed inspection report. Your attention to this issue is requested.

No response to this letter is required. Thank you for your cooperation.
