SUBJECT: ROUTINE INSPECTION NO. 030-20982/94-001

On September 1 and 3, 1993, a routine safety inspection at a radiography field site located in Fairfax, Virginia was conducted by Mr. Jay L. Henson of our Region II office. On March 23, 1994 and April 1, 1994, a routine safety inspection at the above address was conducted and on April 8, 1994, a safety inspection at a radiography field site located near Honey Brook, Pennsylvania, was conducted by Mr. Richard H. Ladun of our Region I office. The inspections reviewed activities authorized by the above listed NRC license and examined your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspections consisted of observations by the inspectors, interviews with personnel, and a selective examination of representative records. In addition, the inspections examined the activities covered in your correspondence dated September 3 and December 3, 1992. This letter also refers to the telephone conversations on April 5 and April 11, 1994 with you and Mr. Richard Ladun.

Based on the results of these inspections, it appears that your activities were not conducted in full compliance with NRC requirements. A Notice of Violation is enclosed as Appendix A and categorizes each violation by severity level in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," 10 CFR Part 2, Appendix C (Enforcement Policy). You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

Please use the enclosed self-addressed green envelope when you submit your copy to the Regional Administrator, Region I. This will assist us in the timely processing of your response. In accordance with Section 2.790 of NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and your reply will be placed in the Public Document Room. The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
