We have received your letter dated March 15, 1994, which transmitted changes to the Fort Calhoun Station Radiological Emergency Response Plan. The plan revision was submitted pursuant to 10 CFR 50.54(q) and incorporated the following changes: (1) EPA-400 changes, (2) form changes, (3) potable water source changes, (4) equipment and decontamination area changes, (5) procedure reference changes, and (6) editorial changes.

We have reviewed the revision and have determined that the changes are acceptable and do not appear to degrade the effectiveness of your emergency planning at Fort Calhoun Station.
