Yerokun, W. O'sen, and D. Lew at the Maine Yankee Atomic Power Plant, Wiscasset, Maine. The inspection involved observations of plant activities and equipment, interviews, and document reviews. The findings were discussed with members of your staff during the inspection period and with R. Plackmore and others of your staff at the exit meeting held on May 4, 1994. Overall, your staff responded appropriately to the issues regarding operability concerns identified with the 4160 Volt circuit breakers and took prompt action to ensure that affected safety related systems would continue to function as required. Engineering performance was excellent as demonstrated by the actions taken to resolve the 4160 Volt circuit breaker issues as well as other ongoing issues. We noted an instance of failure to adhere to the Inservice Test Program requirements when appropriate actions were not taken to address the results of surveillance tests. In accordance with 10 CFR 2, Appendix C, this violation is not being cited because the safety significance was minimal and you took adequate corrective actions to rectify the situation. In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice", a copy of this letter and its enclosures will be placed in the NRC Public Document Room. Thank you for your cooperation.
