Gentlemen:

On March 8, 1993 (Serial: NLS-93-067), Carolina Power & Light Company (CP&L) submitted a response to NRC Bulletin 90-01, Supplement 1 "Loss of Fill-Oil in Transmitters Manufactured by Rosemount" for the Brunswick Nuclear Plant (BNP). In our response to requested Action 1.f, CP&L stated "Rosemount transmitters at BSEP which normally operate at pressures less than 500 psi will be excluded from the enhanced surveillance program."

As discussed with your staff on March 23, 1994, CP&L believes the response to Bulletin 90-01 adequately addressed the concerns identified, since loss of fill oil problems with Rosemount transmitters with an operating pressure up to 500 psi have not been experienced at BNP. CP&L also provided training to BNP instrumentation and control (I&C) maintenance technicians to ensure they are capable of recognizing and appropriately addressing sluggish transmitter responses. In addition, CP&L is including symptoms of oil loss associated with Rosemount transmitters during continuing training to I&C maintenance technicians.
