Subject: Procedure for Handling Draft Midland  
Technical Specifications

This will confirm discussions with Messrs. D. Budzik & D. Wuokko of your Company with Mr. D. Hood on February 23, 1983, regarding submittals of draft Midland Technical Specifications (DTSS) for NRC staff review. The procedure discussed applies only to working drafts during the formulation stage of Technical Specification review. FSAR Chapter 16 submittals, associated meeting notices and summaries and other official related correspondence are not included and will continue to be handled by normal procedures.

Submittals of draft Technical Specifications to the NRC may be limited to 10 copies. The initials "DTS" should be added after the Midland Plant docket numbers appearing on the cover letter. Since such submittals are made for the purpose of ascertaining acceptable specifications (i.e., are a "working" draft), and do not themselves represent the final specification to be proposed, these submittals need not be submitted under oath and affirmation.
