Environmental Review

Public Meeting

- I. Mayor of Elma welcomes persons attending the meeting, Mr. Nicholas Lewis Chairman of the Energy Facility Site Evaluation Council as moderator, and the NRC staff.
- II. Opening remarks by moderator.
  1. Moderator makes any administrative remarks to guide the conduct of the meeting. (ie. sign up sheet used to determine which persons desire to express environmental concerns to the staff, any breaks, specify length of the meeting 7-10:00 PM, etc.)
  2. Invites NRC Project Manager to introduce the NRC staff.
- III. Introductory remarks by the NRC Assistant Director for Licensing.
  1. Explains the purpose of the meeting. (ie. The forum of the meeting is to provide any members of the general public to have direct access to the staff to identify environmental areas of concern which have developed or changed since the CP stage, what topics will not be entertained).
  2. NRC Branch Chief summarizes the licensing process and where WNP-3 is in the process.
  3. Allows each member of the technical review staff to briefly outline their scope of the review for the WNP-3 plant.
- IV. Through use of the sign up sheet the moderator determines which persons desire to express environmental concerns to the staff and invites them to speak. The NRC Assistant Director for Licensing coordinates the staff response and allows comments from the staff.
- V. Moderator maintains general order of the meeting.
- IV. Approximately 15 minutes prior to the end of the meeting, the moderator terminates the public discussion with the staff. The Assistant Director for Licensing summarizes his assessment of the meeting.
- V. Closing remarks by the moderator.
