

those contentions (with supporting bases) it wishes to litigate in this proceeding, see 10 C.F.R. § 2.714(b), and 3) shall file a notice of appearance by its counsel that conforms with the requirements of 10 C.F.R. § 2.713(b); and it is

FURTHER ORDERED, that the existing parties to this proceeding may file a response within fourteen days after service of any amended intervention application and/or contentions supplement filed by the Cherokee Nation pursuant to this order.*
