Upon consideration of the April 20, 1994 application for an order permitting intervention filed by the Cherokee Nation, the May 5, 1994 application answers of Sequoyah Fuels Corporation (SFC) and General Atomics (GA), and the May 10, 1994 NRC staff response to the Cherokee Nation application, it is
