This refers to the inspection conducted by F. N. Wright of this office on April 18-22, 1994. The inspection included a review of activities authorized for your Farley facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

The enclosed Inspection Report identifies activities in the area of labeling radioactive material that violated NRC requirements that will not be subject to enforcement action because the licensee's efforts in identifying and/or correcting the violation meet the criteria specified in Section VII.B. of the Enforcement Policy. Additional management attention to complete and implement effective corrective actions for labeling of radioactive material is warranted as a result. An assessment of the adequacy of corrective actions to prevent recurrence will be made in a future inspection.
