This refers to the routine inspection conducted by Mr. J. J. Kottan of this office on July 6-9 and 19-20, 1982, at the Susquehanna Steam Electric Station - Units 1 and 2, Berwick, Pennsylvania, and at the corporate offices of Pennsylvania Power and Light Company of activities authorized by NRC License No. CPPR-101 and CPPR-102 and to the discussions of our findings held by Dr. J. C. Jang on July 8, 1982, and Mr. J. J. Kottan on July 9, 1982, with Mr. D. J. Thompson and others of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
