

Background: As you know the Nuclear Regulatory Commission (NRC) Operations Center will be moving to Two White Flint North. This move will result in a new Operations Center telephone number. Consequently, the current telephone number published in the Code of Federal Regulations will no longer be valid. The NRC licensees will revise their procedures and any other affected documentation to show the proper (to be determined) phone number for the NRC Operations Center.

AGENCY: Nuclear Regulatory Commission

ACTION: Final Rule

SUMMARY: The Nuclear Regulatory Commission (NRC) is amending its regulations to change the current telephone number at the NRC Operations Center from (301)951-0550 to (to be determined). This action is necessary to accommodate the move of the re. nse center from Bethesda to the new building in Rockville. This amendment will provide the correct commercial telephone number for licensees to contact the NRC Operations Center.

EFFECTIVE DATE: June 30 1994 (30 days from date of publication)

SUPPLEMENTARY INFORMATION: The NRC will soon move its Operation Center from the Maryland National Bank Building in Bethesda to Two White Flint North in Rockville. At this time it will be necessary to use the new phone number to reach the Operations Center. The NRC licensees will revise their procedures

and any other affected documentation to show the proper () phone number for the NRC Operations Center.

This notice is being published to inform the public and NRC licensees of the phone number change.

Since this amendment deals with agency procedures, the notice and comment provisions of the Administrative Procedures Act (APA) do not apply pursuant to 5 U.S.C 553(b)(A). The amendment is effective 30-days following publication in the Federal Register.

Environmental Impact: Categorical Exclusion

The NRC has determined that this final rule is the type of action described in categorical exclusion 10 CFR 51.22(c)(2). Therefore, neither an environmental impact statement nor an environmental assessment has been prepared for this final rule.

Paperwork Reduction Act *statement*

Regulatory Analysis

No regulatory impact analysis has been prepared for this amendment *because it is an administrative action that* since it merely changes the telephone number that is currently being used by licensees under the existing regulations.

Enclosed for the information of the Subcommittee is a copy of a final rule. The NRC has sent to the Office of the Federal Register, for publication, a final rule to amend Footnote 1 of Sections 20.403(d)(2) of 10 CFR Part 20, 30.50(c)(1) of 10 CFR Part 30, 40.60(c)(1) of 10 CFR Part 40, 70.50(c)(1) and 70.52(a) of 10 CFR 70, 72.74(a) of 10 CFR Part 72, 73.67(e)(3)(vii), 73.67(g)(3)(iii), and 73.71(a)(1) of 10 CFR Part 73, the Scope of 21.2(d) of 10CFR Part 21, Footnote 2 of 35.33(a)(1) of 10 CFR Part 35, and Footnote 3 of 50.72(a)(2) of 10 CFR Part 50, to replace the current telephone number (301)951-0550 published in the Code of Federal Regulations to telephone number (to be determined) when dialing the NRC Operations Center.

When a licensee, licensee employee, or contract employee discovers an event reportable under paragraph 73.71(a) or (b), telephone notification to the NRC Operations Center listed in Appendix A to 10 CFR Part 73 should be made within 1 hour of the discovery. Telephone notification should be made via the Emergency Notification System (ENS) if the licensee is party to that system. If the ENS is inoperative or unavailable, a commercial telephone should be used to ensure that the required notification is received by the NRC Operations Center within 1 hour of discovery of the event. The commercial telephone number that may be used to contact the NRC Operations Center is (301) 951-0550. Other methods that may be used to ensure notification within 1 hour include telegram, mailgram, or facsimile. Telegrams and mailgrams should be hand delivered to the Operations Officer at the NRC Operations Center, Maryland National Bank Building, 7735 Old Georgetown Road, Bethesda, Maryland 20814. Whenever a gauge containing radioactive material is involved in an incident or damaged, the RSO and other knowledgeable personnel, such as any radiation safety consultants, should be notified immediately. The licensee should not perform any work that may spread radioactive contamination, in the area of the gauge, until the gauge is checked for leaks. If the incident could result in a significant or uncontrolled spread of contamination, or cause or threaten to cause the situations described in 10 CFR Section 20.403, NRC should be

notified immediately at (202) 951-0550 (twenty-four hours per day).

Problems have been experienced during emergency exercises with the establishment of the HPN, and the following procedure is provided as clarification to address these problems. As the NRC and licensee response facilities become staffed, either the NRC regional office or NRC headquarters may decide that establishment of the HPN is warranted. An announcement of this fact will be made over the ENS. It is important that the licensee provide a technically qualified communicator to staff the HPN as soon as possible after the announcement on the ENS. To gain access to the HPN, the licensee's HPN communicator calls the NRC Operations Center in Bethesda, Maryland, on one of the following telephone numbers (in the order listed): (301) 951-1212, (301) 951-6000, or (301) 951-0550. These telephone numbers are already provided on the sticker affixed to each HPN telephone. (If an HPN telephone does not have the affixed sticker, the licensee can contact NRC Telecommunications at (301)492-8000 to obtain one.) The licensee's HPN communicator indicates that he/she is the licensee HPN communicator and that he/she would like to be connected to the HPN teleconference bridge. It is important that the communicator have direct access to health physics and dose assessment information.
