Subject: Nuclear Regulatory Commission (NRC) Staff Site Visit to Washington Public Power Supply System Nuclear Project No. 3 (WNP-3)

On March 15-16, 1983, the NRC staff will visit WNP-3. This visit is part of the review process for preparing the environmental impact statement related to the operation of the plant. It is of primary importance that all relevant environmental interests are given proper consideration during this review. To support that objective and allow our staff to meet the local officials in the surrounding towns, the utility was offered to set up a separate plant tour on March 15, 1983 for public officials interested in attending and the NRC Assistant Director for Licensing, Mr. Thomas M. In a separate, related matter, the NRC staff plans to have an open meeting with the public on the evening of March 16, 1983. This meeting is to provide a forum for any member of the general public to have direct access to the staff to identify environmental areas of concern. The meeting will be held from 7:00 pm to 10:00 pm in the conference room of the Grays Harbor County Pavillion at the county fair ground in Elma.
