SUBJECT: GA TECHNOLOGIES INC. REQUEST FOR CONSENT TO ACQUIRE RIGHT,  
TITLE AND INTEREST IN NRC LICENSES, DATED JUNE 23, 1982

By letter dated June 23, 1982, GA Technologies Inc. (GA) requested NRC's written consent to acquire by transfer from General Atomic Company (GAC) all of GAC's right, title and interest in the licenses and license applications (reactors, special nuclear materials, byproduct devices, certificates of compliance, export and import). Their request is made so they can formally close the agreement between Gulf Oil Corporation and Scallop Nuclear Inc. (partners in GAC).

We have reviewed the special nuclear material and byproduct licenses and the certificates of compliance and associated quality assurance program (all under NMSS) and give consent for GA to acquire by transfer all of GAC's right, title and interest in the licenses and license applications in the three categories under the jurisdiction of NMSS. However, at the time of the transfer, amendments will be required to the related licenses. Since GAC has already submitted the fees for the amendments, they should notify us of the closing date for the change in ownership and then we shall issue the appropriate amendments.
