SUBJECT: REVISIONS TO FUNDAMENTAL NUCLEAR MATERIAL CONTROL PLAN
(TAC NO. L30659)

This is in response to your letters and enclosures dated March 21, 1994 and May 19, 1994, by which you submitted 62 revised pages to your Fundamental Nuclear Material Control (FNMC) Plan. The second submittal modified 13 pages of the prior submittal, and such modifications resulted from discussions between members of your staff and Mr. Don Joy of my staff.

Our review has confirmed that the revisions to your FNMC Plan, as contained in your May 19th submittal, qualify as changes allowable under the provisions of 10 CFR 70.32(c), and thus are acceptable. Accordingly, we are hereby revising License Condition SG-1.1 of Materials License SNM-1097, effective immediately, to incorporate the above mentioned FNMC Plan revisions. Revised Condition SG-1.1 reads as follows:

SG-1.1 The licensee shall follow Sections 1.0 through 9.0 of its Fundamental Nuclear Material Control Plan dated December 16, 1987, and which has been revised as indicated by Revision 22 of page 1 (dated May 19, 1994 and titled "Revision By Page") of said Plan. This Plan may be further revised in accordance with, and pursuant to, the provisions of either 10 CFR 70.32(c) or 70.34.

All other conditions of this license shall remain the same.

We have determined that the enclosures to your letters dated March 21, 1994 and May 19, 1994, contain information of the type specified in 10 CFR 2.790(d). Accordingly, pursuant to Section 2.790(d)(1), such information is deemed to be commercial or financial within the meaning of 10 CFR 9.17(a)(4) and shall be withheld from public disclosure unless subject to the provisions of 10 CFR 9.23.
