This letter refers to the safety inspection conducted by Ms. Mary Cahill of this office on April 26 - 28, 1994, of activities authorized by the above listed NRC license, and to discussions of the findings held by the inspector with you and members of your staff on April 27 and 28, 1994. The inspection was limited to examination of licensed activities at the Scranton, Bala Cynwyd, and Yardley, Pennsylvania facilities. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. Areas examined during the inspection are described in the NRC Region I Inspection Report which is enclosed with this letter (Enclosure 1). Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews of personnel, and observations by the inspector.

As discussed during the telephone conversation between you and Dr. Ronald Bellamy of this office on May 18, 1994, the apparent violations identified during the inspection will be the subject of an enforcement conference to be held in Region I. The enforcement conference will begin at 10:00 a.m. on June 8, 1994. This enforcement conference will be open to public observation in accordance with the Commission's trial program as discussed in the enclosed Federal Register Notice (Enclosure 2).

The purposes of this conference are: to discuss the apparent violations, the cause(s) and safety significance; to provide you the opportunity to present your corrective actions accomplished and proposed; and to discuss any other information that will help us determine

the appropriate enforcement action. You should also be prepared to discuss the oversight of your radiation safety program by management and the Radiation Safety Officer, and your present and future plans to oversee the use of radioactive materials at the numerous facilities authorized on your license.

Enforcement action for the violations will be considered by the NRC following the conference. The NRC Enforcement Policy is described in Appendix C of 10 CFR Part 2, a copy of which is enclosed for your information (Enclosure 3). Directions to the NRC Region I Office are also enclosed (Enclosure 4).
