Now therefore in consideration for accepting late delivery of 10 of the leased vehicles the contractor shall provide and the Government shall accept other vehicles (previously leased to NRC under contract number NRC-10-80-371) as substitutes until delivery of the new vehicles. The lease of these older vehicles (from NRC-10-80-371) for the period May 14, 1982 through May 28, 1982 shall be at no cost to the Government.

Article III - Deliveries/Performance, Paragraph B. Time of Delivery - delete in its entirety and substitute the following:

"Three of the vehicles described in Items 1 and 2 under Article I shall be delivered by 10:00 AM, May 14, 1982. The remaining seven vehicles shall be delivered as shown below.

May 20, 1982 - 1 vehicle
May 26, 1982 - 3 vehicles
May 27, 1982 - 2 vehicles
May 28, 1982 - 1 vehicle

The term of the contract lease shall be from May 13, 1982 through May 13, 1983.

Article IV - Obligation of Funds and Compensation add the following sentence:

"However the Government shall not be obligated to pay any cost for lease of seven vehicles for the period from May 14, 1982 until date of actual delivery and the invoice for that period shall be adjusted accordingly."

This Supplemental Agreement does not affect any other rights the Government may have under this contract.
