### PROCEEDINGS

ACTING CHAIRMAN AHEARNE: We meet this afternoon for an affirmation session. Sam.

MR. CHILK: The first paper is SECY-82-323. It is an interpretative rule providing guidance on immediate effectiveness decisions where the Commission is being asked to approve a <u>Federal Register</u> notice announcing the adoption of an interpretative rule regarding the weight of authority to be accorded by Licensing and Appeal Boards to the Commission's effectiveness decisions.

The Chairman, Commissioners Ahearne and Asselstine have voted to approve the <u>Federal Register</u> notice. Commissioner Gilinsky and Roberts are opposed. Commissioner Roberts has indicated he will have separate views.

Would you please affirm your votes?

COMMISSIONER GILINSKY: I guess we are not going to have any discussion.

(Laughter.)

MR. CHILK: Would you please affirm your votes? (Chorus of unanimous ayes.)

ACTING CHAIRMAN AHEARNE: Will you hold that so that he can get his views in?

MR. CHILK: Yes, oh, yes. The second paper is SECY-82-339, the Clinch River Stay Request where the Commission is being asked to approve an Order that would deny a motion by NRDC and the Sierra Club of a stay of the order granting the exemption under 10 CFR 50.12 for the Clinch River Breeder Reactor.

Commissioners Ahearne, Roberts and Asselstine have voted to approve the order. Commissioner Gilinsky has voted to disapprove it. Chairman Palladino is not available to participate. Will you please affirm your votes? (Chorus of unanimous ayes.) MR. CHILK: Thank you. That completes it.

ACTING CHAIRMAN AHEARNE: Thank you. We now stand adjourned.
