Dear Mr. Akst:

This is in further response to your letter dated April 27, 1982, in which you requested, pursuant to the Freedom of Information Act, any and all documents relating to NRC activities concerning Sheffield Brook in Wayne, New Jersey, along with any other material relating to or stemming from any radiation in Wayne, New Jersey.

Seven additional documents have been found subject to your request. Two documents have been forwarded to DOE for direct response to you and the remaining five are listed in Appendix A hereto.

Document number 1 is released in its entirety. Please note that portions of documents 2-5 containing home telephone numbers have been deleted. Because disclosure of this information would constitute a clearly unwarranted invasion of personal privacy, they are being withheld from public disclosure pursuant to Exemption 6 of the Freedom of Information Act (5 U.S.C. 552(b)(6)) and 10 CFR 9.5(a)(6). The non-exempt portion of these documents are enclosed.

Pursuant to 10 CFR 9.9 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure and that its production or disclosure is contrary to the public interest. The persons responsible for this denial are the undersigned and Mr. Ronald C. Haynes, Regional Administrator, Region I.

This denial may be appealed to the Commission's Executive Director for Operations within 30 days from the receipt of this letter. As provided in 10 CFR 9.11, any such appeal must be in writing, addressed to the Executive Director for Operations, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision."


