
## **TSTF 2019 Retrospective**


- 2020 marks the 17th year (2003) of the TSTF as a jointly sponsored Owners Group activity (25 years as an organization, 1995)

## **TSTF 2019 Retrospective**

- The NRC expended 1,253 hours reviewing travelers in 2019.
- The TSTF exchanged 26 letters with the NRC:
  - o 14 from the NRC (excludes meeting notices and summaries)
  - o 12 from the TSTF
- The TSTF held 13 meetings and 15 teleconferences with NRC.
- Other TSTF Activities:
  - Withdrew recommendation for adoption and removal of commitments regarding TSTF-493, "Clarify Application of Setpoint Methodology for LSSS Functions," 6/18/2019.
  - Supported the NEI Regulatory Issues Task Force (RITF) on completion and issuance of NEI 18-03, "Operability Determination."
  - Supported the NEI Risk Informed Technical Specifications Task Force (RITSTF) in resolving the use of new PRA methods with TSTF-505, "Provide Risk-Informed Extended Completion Times."
  - o Supported the EPRI Steam Generator Management Program (SGMP) in development of changes to the TS-required inspection frequencies for steam generator tubes.
